Hepatitis A Vaccination (adult 19> years)	\$49.40 <i>Hep A is not in stock; please see nurse to see if we can order</i>
Influenza Vaccination & Administration	\$35.00
Lead	\$4.10 <i>(nurse's visit fee may be required if not in conjunction with another service)</i>
Lice Combs	\$12.00

Pregnancy Test	\$2.58 <i>(nurse's visit fee also required with test)</i>
